63/525. Question of Gibraltar

At its 64th plenary meeting, on 5 December 1984, the General Assembly, on the recommendation of the Special Political and Decolonization Committee (Fourth Committee),<sup>50</sup> recalling its decision 61/51, of 19 December 1976, and the statements agreed to by the Governments of Spain and the United Kingdom of Great Britain and Northern Ireland in Brussels, on 12 November 1984,<sup>51</sup> and in Madrid, on 14 October 1984, and noting the establishment, pursuant to the latter, of the tripartite forum for dialogue on Gibraltar, separate from the Brussels process, under the statement made jointly by the Governments of Spain, the United Kingdom and Gibraltar on 6 December 1984<sup>52</sup>

(a) Urged both Governments, while listening to the interests and aspirations of Gibraltar, to reach, in the spirit of the statement of 12 November 1984, a definitive solution to the question of Gibraltar, in the light of relevant resolutions of the General Assembly and applicable principles, and in the spirit of the Charter of the United Nations<sup>53</sup>

(b) Welcomed the ongoing successful implementation of the first package of measures concluded at the tripartite forum for dialogue on Gibraltar and the shared will to reach new agreements by July 1989.

63/526. Increase in the membership of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples

At its 64th plenary meeting, on 5 December 1984, the General Assembly, on the recommendation of the Special Political and Decolonization Committee (Fourth Committee),<sup>54</sup> decided to increase the membership of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples from twenty-seven to twenty-eight.<sup>55</sup>

63/527. Proposed programme of work and timetable of the Special Political and Decolonization Committee (Fourth Committee) for the sixty-fourth session of the General Assembly

At its 64th plenary meeting, on 5 December 1984, the General Assembly, on the recommendation of the Special Political and Decolonization Committee (Fourth Committee),<sup>56</sup> approved the proposed programme of work and timetable of the Committee for the sixty-fourth session of the Assembly, as contained in the report of the Committee.<sup>54</sup>
